- 5. Must be in school and have a "C" or above grade point average, unless you have already graduated.
- 6. Must have basic knowledge of the Miwuk culture.
- 7. Must have no violations with the law.
- 8. Must be single and have no children, no common-law marriages, or current non-wed live in situations accepted.
- 9. Must provide any verification when requested by the Princess Coordinators throughout the contest for the 2002-2003 year.
- 10. Must be available for crowning, ceremonies, publicity, parades, local Indian gatherings, etc. from Mariposa Pow Wow 2002-2003.
- 11. Must wear Indian regalia for entire Pow Wow. Must provide own regalia (assistance will be given upon request).
- 12. Must provide/ be available to provide a picture for publicity.
- 13. Must provide transportation to events and be accompanied by a parent or guardian.
- 14. Parents/ Guardian are liable for all tickets and monies not turned in.
- 15. All tickets must be turned in by Monday, May 6, 2002 by 5:00 PM to Princess Coordinators at Mariposa Indian Council in order to count towards the princess contest.
- 16. The winner is determined by: an Interview, a Talent, an Essay, and ticket sales. (Dates will be announced for the interview and talent portions).
- 17. The winner will receive a Beaded Crown, a Sash, a Gift, and \$50.00/ or 10% of their ticket sales.
